For the first 2 weeks he was fed specially formulated flying fox milk from a syringe and teat. He had burns in his throat which made suckling painful for him but after 2 weeks he was able to drink from a bottle and teat.

He grew quickly and by 9 weeks old he was beginning to fly. All species of flying foxes bond with their carers and have very different personalities, just like your pet dogs. All wildlife carers have to be vaccinated to rescue and care for these delightful critters.

Every rescued and released native animal, bird or reptile in my view is important. If we want to preserve the native wildlife that remains we need to care for all creatures, so if you see a critter in trouble please take the time to ring your local wildlife hotline.

Go further if you are able and join NTWC. We are always looking for people to help with animal care, for people who are able to transport injured animals, for phone operators and people with computer skills. Training is given and you will become part of a group of caring environmentally aware women and men that will be happy to welcome you, there is no better feeling than seeing a critter released

September saw Southern New England Landcare welcome their newest team member to work on two projects with farmers and graziers across the region.

Aggie (Alexandra) Seiler will be based in Armidale and her work will focus primarily on assisting farmers to build landscape resilience in the face of a changing climate.

When not at work Aggie is finishing her Diploma of Agriculture and working alongside her husband on their family-run cattle grazing enterprise near Guyra.

"Becoming part of the farming community of the New England has been such a wonderful experience," said Aggie.

"My new role with Southern New England Landcare is an opportunity for me give back to the local farming community," she said.

Aggie began her studies in a Bachelor of Science at the University of Queensland, studying plant and animal biology, ecology, genetics, and chemistry.

However, she went on to study nursing and later became a Community Nurse working in rural areas across the top end of Australia.

"My career change into the agricultural sector might seem incongruent, but it's all about health and people... the health of the people is interconnected to the health of the land," she said.

Over the next two years, Aggie's activities with the Resilient Pasture Landscapes project will include working with farmers in the region to build skills in climate forecasting for feed budgeting purposes and pasture management, soil testing, farm water supply and water management and using software tools to monitor and track changes over time.

Aggie will also be working in the role of the Malpas Catchment Coordinator, bringing some 'movement to the Malpas' by working with the well-established Malpas Catchment Group.





Uralla Community Co-operative Ltd AGM

The Annual General Meeting of Uralla Community Cooperative Ltd drew twenty members to the Hill Street shop on Saturday 1 October to hear reports of activity in the financial year recently ended. The Chairman reported that the Co-op is now a registered charity. Premises at 119 Bridge Street have been leased which will house a workshop and offer higher end recyclables and hardware, while Hill Street will continue to house the op shop and a yard of building materials, gardening, etc. Thanks were recorded to the board, the volunteers, the members, and donors and sponsors, all of whom contributed to a significantly successful year. The financial report showed turnover of \$68,000, a surplus of \$48,000, and distributions of \$24,000 to thirty local organisations. Activity since July shows income of \$21,000 and

expenditure of \$15,000 including the acquisition of a van to be used for pickups and deliveries. The meeting appointed Grahame Sharpe to review the financial reports.

All Directors resign at the end of each year. Four current Directors stood for re-election, as did six other members, so an election was necessary to select the eight Directors allowed by the rules. Bob Anderson officiated for the election, assisted by Angus McLean. It was pleasing to see so many members prepared to offer their time and energy to keep the Co-op running smoothly, and that over fifty members voted (about thirty of them by proxy, this being a long weekend of which the Board were oblivious when they chose the date). The successful candidates were Peter Barkley, Ross Burnet, Peter Ellston, Christina Goodwin, Karin Jackson, Leonie Kirwan, Tim Robertson, and Helen Vastenhoud, who will hold their first board meeting within the next fortnight.

Running Wild Big Rains - Episode 3

4. Recap: The floods had wreaked havoc at the Thompson Farm, but not so that it couldn't be fixed. New potato and pumpkin crops were quickly replanted. Nellie's earlier life was with her people, far south on Gweagal Country. It was here she visited the Pleasure Gardens, in the grounds of Sir Joseph Banks Hotel, Botany Bay.

An arena enabled circus acts and musicians to perform and there was a horse riding stables around behind the hotel. Yacht regattas were held on the waters of 'The Bay' and 'Pedestrian Contests', as they were known, became the talk of the colony and all the way back to Europe. International runners came to compete in the Sir Joseph Bank Handicap, against the best of local talent, including aboriginal runners of note. Regular football and cricket matches were played on the oval and the Boxing Day celebration were attended on mass.

It made for a fine 'cultural visit' in these early times, where the common folk and aboriginal people mingled with high society, and where sailors and soldiers let off steam. The grog was always on offer, a card game or dice, but the military kept the high society patrons oblivious to these other world antics, and they were generally none the wiser from their visit.

Mr Blanch was a retired Ships Surgeon, taking up two rooms of permanent lodgings at the Banks Hotel. One of the rooms he converted for patient examinations and dispensed his own brand of medical services to the many visitors of the Pleasure Gardens and local first people.

He was a man in his later years, having seen the theatres of war on many distant shores, while in the service of the Royal Navy, 'from Algiers to the China Sea', he would say. Although his health was likely poorer for a man of his age, due to his liking for rum and the opium that the Chinese hawked in every alleyway of the growing Sydney colony. However, he said the opium numbed his mind when the demons of war came calling.

His practice and treatments were seen as unorthodox by those formally trained physicians, but many folk were grateful for his skills, whether the setting of a broken bone, the stitching of a bullet wound or tending the sick and dying. Often his services were called upon to patch men after brawling, a knife fight or worse.

He accepted payment of all sorts, from gold, foods to opium, making him the doctor of the rich, poor and criminal alike. His interest was also in tending of the local first people, for he had seen first-hand the death and suffering the colony and white settlement had bought upon this proud people.

Nellie became acquainted with Mr Blanch while she was serving as a housemaid at the hotel. On numerous occasions she had helped him to his room, when he had taken a binge of the rum or opium. It wasn't long before Mr Blanch needed the services of a maid and cleaner at his practice, and one who could speak the local aboriginal dialects. Nellie fitted the position perfectly and soon she become indispensable, acting more like his assistant than maid. But outwardly she would always be his servant.

Dear Editor.

According to the September council newsletter, Uralla Court House is to have the recently installed roofing and solar panels removed. To be replaced with galvanised roof sheeting and solar panels removed and installed else where. This was further endorsed by Consultant Gordon Fuller in Wordsworth on Monday 19th September..

My question, is why is this change happening now after both have been installed?

Council's decision to install galvanised sheeting 'just went out the door' to its own and NSW State planning regulations. That no galvanising sheeting is to be installed on any building in residential areas. Because of the glare it creates. This regulation would have been the reason why the roof

was re-roofed and the cream coloured installed many years ago.

The time to decide what is to be fitted to the building was when the application for funding was done, as the council has to comply with the approved grant or apply for a change of usage. Why change now after installation has been done. The announcement some time ago that the council received over \$900,000 grant money to improve the vacant building, said:

New roof including installation, solar panels, paint the building and change the interior to make it suitable for

community use will be done to the Uralla Court House building.

One would understand from this announcement, the new roofing would match existing roofing colour and solar panels would be installed on the Court House roof. The roofing and solar panels has been done with other work continuing.

The decision to change the usage of this building, from an empty vacant building, to an asset for the residents and community of Uralla was good and will benefit all.

Because of this change, having solar panels on the roof does not take away from the historic value of the Court House, we must move forward and not live in the past.

Looking to the future to reduce energy costs installing solar panels on any roof on any building will need to be accepted by people. Especially as this building will be used by the community.

The Community Centre roof colour matched the Court House roofing, when this building was constructed some years ago,

The only offending building on this site is a small shed which does not have the colour of the roof matching other buildings. It would be nice to have this roof changed to match the other buildings.

We now have consultant Fuller telling the council and the community it will have to put up with the glare from the Court House roof when the roof is changed to galvanised sheeting. I question the historic value to do this to the detriment effect it will have on this most important intersection of Uralla.

Uralla Shire Council have made announcements that its funds are very tight and they are reviewing their expenditure.

I am concerned as a rate payer that council has now made a decision to change what is happening on the Court House with additional expenditure to remove the sheeting and solar panels then reinstall them.

I ask how Council spending money on changes now, to the Court House building, is a suitable choice when they do not have the money to do so. Is this trading in an insolvent position and should an Administrator be appointed because of their foolish decision?

My key issue with Survey Monkey is best explained by the old anomaly: rubbish in, rubbish out. Question writing and analysis of results is a specialist skill. It is too easy to (even inadvertently) skew questions to influence a result.

Survey Monkey, when used well, is a useful form of community engagement but it should not be prioritised over soliciting considered written responses to complex issues. Uralla Shire is lucky enough to be home to people with vast experiences. What a shame it would be to lose voices who take time to examine documentation in detail, and instead depend on a monkey.
